The ground work for **IOACON 2024 Bengaluru** has begun and the registrations have started.



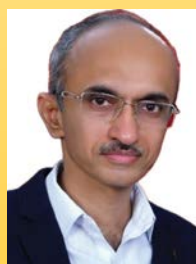

MINUTES OF THE KOA EGM 2023

Venue: Hall 'A'. KLE Centenary Convention Centre, Belagavi

Time: 03.30 pm

Members Attended: 120

The meeting started at 03.30 pm after the quorum was reached.

The President Dr. Aswani Kumar Singh J. called the house to order.

The Secretary General welcomed all the members to the Extraordinary General Body.

The President addressed the members and mentioned the need for calling the EGM. He mentioned that as per the resolution of the previous KOA AGM 2022 a Constitutional Review and Blue Book formation Committee was formed with Dr. Suresh Korlahalli as the Chairman, Dr. Sachidananda Rai B. as the Convenor and Dr. Uday Kumar B as the member.

The Secretary General Dr. Bharath Raju G. invited the Constitutional Review Committee Chairman Dr. Suresh Korlahalli and Convenor Dr. Sachidananda Rai B. to come to the dais.

The Secretary General mentioned that the Draft of the Proposed Constitutional Amendment and Blue Book has been circulated to all the members one month back and the members were given time of three week to propose or suggest changes in the draft copy.

The Secretary General requested the Chairman of Committee to present the Draft of the Constitutional Amendment and Blue Book.

Dr. Suresh Korlahalli thanked the EC for forming the committee and appreciated the efforts of Dr. Sachidananda Rai in preparing the draft.

Dr. Suresh Korlahalli mentioned that the draft has been circulated to all the members three times requesting the members to suggest changes or proposals if any.

He said that only one recommendation has been received on few points in the draft from KOA Past President Dr. V.J. Purushotham.

The Secretary General read out the mails as received from Dr. V.J.Purushotham.

Mail 1.

Points I have noted in the recommendations for amendment of By-Law

BLUE BOOK:

- 1) The registration fee: Instead of 10% increment it can be maximum of 10% so the organizers can decide on that instead of fixed one
- 2) Conference: Satellite halls can be minimum of two and minimum of 100 capacity, as the halls will be sparsely occupied many times;
- 3) Banquet should be free, included in the conf registration fee; once we have more than 2000 conference attendees, we can consider separate fee in due course

CONSTITUTION

- 1) 2: membership fee; is it still 1100? It should be increased to 3k, considering many city clubs it is 2k and IOA it is 5k
- 2) 6 a: AGM can be hybrid, so more members can attend
- 3) 8; 11; Secretary general is elected one as its not mentioned here; term of 3 years
- 4) 9 b; joint secretary and treasurer term can be 1 year; can be renominated: if they are elected then it can be for 3 years
- 5) e) EC members should be proportion to the size of the association; may be like one for 125 members; at present number it should be 11; 7 elected & 4 nominated
president should be allowed to have co-opted members, whom he feels necessary for the said meetings or the activities of the association
- 6) 11: iv; before suspending the association should issue notice, with due time to the member who is in question; after that it should be placed in the AGM and again it should be notified before the AGM to the member
- 7) 13 11: is election for joint secretary and treasurer? in point number 8 it clearly says no election for the said post
- 8) 13: Like in any association the president elect should be election officer, so that the office is not Mis used by any
- 9) 13: b and C are same points
- 10) There's no mention how president elect is elected; in old by law, it says by its members in its annual meeting; so, it should be by election preceding to AGM, by all members of association: NO ROTATION /ZONES for this post.

Mail 2.

Dear office bearers of KOA

In addition to the points I had sent to you in my previous mail I would like to add an important point which I forgot to mention.

The by law proposes to reserve the election of president elect to region wise which defeats the purpose of any association; the fundamental principle of any democratic constitution is that the entire members choose their leader, president here, one among the entire members. This is written in our by law.

In 2014 when we placed a referendum to this point it was defeated by only 15% members supporting it.

The registrar of societies had then clearly stated that if any such intention is thought , the entire by law has to be changed with either dissolving the association , where in 75% of the total members supports it.

So I request the secretary, Dr Bharath, who's the custodian of our association to get the legal and registrars opinion in this regard and place it before the SGM , to avoid any further legal battle we may have in due course.

To uphold the sentiments of some regional members some other methods can be thought to have equal representation than changing the by law.

As former secretary I have put my efforts in this regard , hence do consider this point while discussing in this

Mail 3.

Dear office bearers

Please allow me to make one clarification with respect to the objection I have raised regarding reservation of presidents post.

I have only objected to the point of it being put in the amended by law , which is unconstitutional. I support the idea of rotating the president post region wise by any other means to without alerting the by law.

It can be put up in the blue book, which is legally safe, and the method can be explained there.

My suggestion.

To have a team of past presidents representing from each zone (3 each from each zone) who can look into the contenders and advice on them if rotation is altered. However constitutionally it will not be supported if someone wants contest even after intervention; but will streamline in the future.

My suggestion can be put up quoting my name.

Thanks.

Dr. Suresh Korlahalli said that these recommendations shall be discussed when that point is presented in the draft.

Dr. Suresh Korlahalli said that he shall read out the circulated draft as it is and if there are any objections to any point the members might suggest the same.

Membership:

Dr. H.S. Chandrashekar stressed that Affiliate Members will not have voting rights and cannot contest for any post.

Dr. Saidapur said that the eligibility qualification for an Affiliate Member should be any degree recognised by the National Medical Council. The President said it has been mentioned.

Dr. Vinod Kumar mentioned that the Membership Fee has not been mentioned. Dr. Sachidananda Rai said that it is as prescribed by the association from time to time.

Dr. Vanamali wanted to know the status of the existing non-resident members. Dr. Suresh Korlahalli clarified that the Affiliate Membership will be prospective and it cannot be retrospective as the said membership category was not present when the member has applied for the membership and the same has been ratified by the AGM then.

Dr. Shiddana Patted wanted to know the status of the Associate Members after completing their qualification degree whether Life Member or Affiliate Member. The President said that based on the residence of the Associate Member he will become a Life Member or an Affiliate Member.

Dr. Gururaj Murgod wanted to know if an Associate Member takes Life Membership and goes out of state for Fellowship, whether he will be eligible for Life Membership. Dr. Suresh Korlahalli clarified that as long as the member is a permanent resident of Karnataka, he can be Life Member. The proof of address can be verified by Aadhar.

Dr. SB Kamareddy said that as the number of Affiliate members is less, they can be given voting rights and can be prevented from contesting elections. The President asked the house and the house unanimously said that voting rights should not be given for Affiliate Members.

Dr. H.C. Shivakumar said that only foreign nationals should be given Affiliate Membership and all Indian nationals should be given Life Membership. The President said that it cannot be done as it is a State Association and only residents of Karnataka can be Life Members.

The Membership categories were passed without any changes proposed by Dr. Deepak S. and seconded by Dr. Gururaj Murgod.

Dr. Suresh Korlahalli read out the other points in the draft. All the points were approved as mentioned in the draft.

Executive Committee Members:

The number of Executive Committee members is nine, six are elected and three are nominated by the President. Dr. Suresh Korlahalli mentioned that Dr. Purushotham has suggested having one EC members for every 125 members, as it will be a large number, he suggested having One EC Member for every 200 or 250 members.

Dr. H.S. Chandrashekar wanted to know the pattern of IOA EC members. The Secretary General clarified that in IOA the affiliated State Chapter President and Secretary are EC members plus any affiliated State Chapter will have one State Representative and an affiliated State Chapter with more than 500 IOA members will have two state Representatives. The maximum number of State Representatives is two.

Dr. Chandrashekar asked for the number of KOA members at present. The Secretary General said that as per the existing records the number of KOA members is 1888.

Dr. Vinod Kumar said that as the number of KOA members is 1888, the existing EC members strength is 9, hence the formula of one EC member for every 200 member is fulfilled and it need not be discussed further.

Dr. Sachidananda Rai said that as and when the member strength increases the number of EC members has to be increased. The General Body passed the resolution that for every 200 KOA members there shall be one EC member, and the same has to be increased from time to time. Proposed by Dr. Vanamali and seconded by Dr. Saidapur.

The General Body passed a resolution that two thirds of the EC members shall be elected and one third of the EC members shall be nominated by the President of KOA. Proposed by Dr. Srinivas Reddy and seconded by Dr. Devendrappa.

Dr. Suresh Korlahalli continued reading the drafts and the general body accepted the same without any changes.

Standing Committees: The formation of various standing committees and the guidelines was appreciated by the General Body and the same was passed without any changes. Proposed by Dr. Narendra and seconded by Dr. Somashekar.

Dr.Suresh Korlahalli continued reading the draft.

The Election of Officers of the Association:

For the **Clause 13.III** Dr. H.S. Chandrashekar said that to be a President Elect or Secretary General of the association a member should have been an EC member for atleast one year to know the functioning of the association, as the affiliated District Chapter President / Secretary are not KOA EC members that point has to be removed. Dr. Suresh Korlahalli said that this point was discussed at length before being added to the draft and as there are many eligible members in the association it was added to give opportunity to the members.

Dr. Gururaj Murgod said that as the EC members will be less that point has to remain as the same.

Dr. Shivakumar said that the point can remain as it is for the Secretary General post but to contest for President Elect a member should have been an EC member.

Dr. Sridharamurthy said that the affiliated District Chapter President and Secretary can be nominated as KOA EC members.

The President clarified that by approving the suggested changes a greater number of members will be getting an opportunity to contest for the post of President Elect and Secretary General.

Dr. Mallikarjunaswamy said that the President's privilege to nominate EC members should not be changed.

Dr. Gururaj Murgod suggested adding the point of IOA State Representative from Karnataka being eligible to contest the post of President Elect / Secretary General. Dr. H.S. Chandrashekar appreciated this and said the same has to be included. The General Body passed the resolution to include the IOA State Representatives in Clause 13. III. Proposed by Dr. Vanamali and seconded by Dr. Kulakarni.

For **Clause 13.IV** Dr. Suresh Korlahalli said that Dr. Purushotham has recommended changes. Dr. Chandrashekar said that this point has been discussed extensively in the Executive Committee meeting, it is the fundamental right of a member to contest for the elections the point should not be added and rotation should be limited for conduction of the conference. The contestants can have mutual understanding to contest for elections zone wise as per the Mysore formula. He also said that as we are following the guidelines of the IOA this point should not be added.

Dr. Sachidananda Rai said that OASIS has state wise rotation.

Dr. Mallikarjunaswamy reiterated the points raised by Dr. Chandrashekar and also said that OASIS is not an affiliated chapter of IOA.

Dr. Kaladagi said that to give opportunity to members of all the zones this point has to be retained.

Dr. Neelanagowda Patil said that the point has to be retained.

Dr. Gangadhar Umarani said that if the zonal rotation is introduced the members from other zones will not participate actively in the election process.

Dr. Gururaj Murgod said that if there can be mutual understanding to contest the elections the same can be retained in the bye-law amendment.

Dr. Hosangadi said that if a member does not honour the understanding he shall be going against the association, to prevent the same it has to be retained.

Dr. Harish Murthy said that in the past the Mysore formula has not been honoured hence it has to be retained in the bye-law.

Dr. Deepak suggested that instead of having this point as a bye-law it can be added as a guideline in the Bluebook.

Dr. Mallikarjunaswamy said that this cannot be amended in the general body.

Dr. Gururaj said it can be done as per the Societies Act.

Dr. Puneet Chamakeri said that this point has to be retained.

Dr. Vanamali said that there should not be rotation for President Elect post.

Dr. Satish Shervegar said we should not follow OASIS guidelines and accept IOA guidelines as it is our parent association. He also said that this point may have legal implications if any member goes to court.

Dr. Edward Nazareth that the legal implications have to be considered.

Dr. Shivakumar and Dr. Vinod Kumar said that this point cannot be passed in this general body cannot pass this resolution. The Secretary General clarified that the Constitution Review and Blue Book Formation Committee was formed as per the KOA AGM 2022 resolution and this extraordinary general body is called for the single agenda of Constitutional Amendment and Blue Book Formation.

Dr. Chandrashekar requested this particular point to be deferred as it will cause disharmony among the members.

Dr. Neelanagowda Patil objected to the same.

Dr. Muralidhar suggested having an online voting by all the members for this point. He also said that when the requirement criteria to contest for the post of President Elect is broadened to give opportunity to all members, the zonal rotation narrows the chances of the members. He also suggested having a post of Working President from the conference zone.

Dr. Purshotam Shastry said that any amendment has to be deliberated at length and only then incorporated in the bye-law.

Dr. Vanamali said that as the President of Bangalore Orthopaedic Society he would like to bring to the notice of the general body that there is a lot of resentment from the members of Bangalore Orthopaedic Society for the above point and the consequences has to be discussed in detail before passing this point.

Dr. Sachin Revankar said that as there is reservation in assembly elections this point can be passed.

Dr. Deepak requested to continue with the Mysore formula for another 5-6 years and if there are any violations this point can be added in the bye-law.

Dr. Kanakachalapathi and Dr. Shiddana Patil said that there will be no disharmony and this point has to be incorporated.

Dr. Parthasarathy suggested having an online voting for this point as there are less members in this general body from Bengaluru. He also mentioned that as the members strength from Bengaluru and the aspirants are more the rotation should be every alternate year to the Central Zone.

Dr. Venkatesh Mulimani suggested having two Bengaluru zones.

Dr. Neelanagowda Patil objected to the same.

Dr. B.B. Putti said that the association should be united and function by mutual understanding.

Dr. Ravishankar said that the existing pattern of KOA Elections has to be maintained.

Dr. Roshan Kumar said that as a member it is the right of every member to contest the elections.

Dr. Sreenivas suggested that the existing pattern of elections has to be continued and it should be KOA as one unit and not divided as zones.

The President said that the Mysore formula has been violated only on two occasions and to prevent such a situation the amendment should be in writing in the bye-law. The President suggested that it can be added that the Election to the post of president Elect shall preferably be on a rotation basis by mutual understanding among the three zones, as per the conference rotation.

The general body wanted to know what if a member violates the understanding.

Dr. Chandrashekar suggested forming a committee of KOA Past Presidents to look into the violation of the understanding.

The President proposed that the committee shall comprise of KOA Past Presidents from the three zones and they shall look into the nominations and if some member violates the understanding, they should ensure withdrawal of candidature by that member.

The general body unanimously passed the Clause 13.IV as the Election to the post of president Elect shall preferably be on a rotation basis by mutual understanding among the three zones, as per the conference rotation. A committee of three KOA Past Presidents from the three zones shall look into the nominations and if there are any aberrations to the understanding shall take suitable action. Proposed by Dr. Ravishankar and seconded by Dr. Venkatesh Mulimani.

For **Clause 13. VI** Dr. Muralidhar said that the restriction on the Organising Chairman and Organising Secretary of KOACON to contest for the Elections in the year of the conference has to be removed. Dr. Mallikarjunaswamy said that point should not be changed and remain as it is. The general body unanimously passed the clause as in the draft. Proposed by Dr. HR Katti and seconded by Dr. Ravi Mukarthihal.

Dr. Suresh Korlahalli continued reading the draft.

For **Clause 13. VII** the Secretary General shall be the Election Officer, Dr. Purushotham had recommended the President Elect as the Election Officer. The general body unanimously rejected the recommendation and passed that the Secretary General shall be the Election Officer as existing. Proposed by Dr. Hosangadi and seconded by Dr. Anirudh Kulkarni.

Dr. Suresh Korlahalli continued reading the draft.

The general body passed all the points in the Constitutional Amendment Draft without any changes. Proposed by Dr. J.N. Sridharamurthy seconded by Dr. Sudheendra.

Blue Book:

Dr. Sachidananda Rai read the Blue Book draft.

The general body deliberated on percentage of the contribution from the Local Organising Committee to the KOA.

The President said that the matter has been discussed in every AGM and proposed that the contribution should be fixed at 7.5% of the total net collections.

The general body unanimously approved that 7.5% of the total net collections from the Conference (including all types of sponsorships, registration for workshops, CME, main Conference, Trade Exhibition stalls, Advertisements for Souvenir, and other miscellaneous collections) without deduction of service tax/TDS or any Govt. Tax shall go to the KOA. Proposed by Dr. Deepak S. and seconded by Dr. Purshotham Shastry.

Dr. Sachidananda Rai continued reading the Blue Book draft. The recommendations by Dr. Purushotham were mentioned at the relevant point.

The general body unanimously passed the Blue Book draft without any changes. Proposed by Dr. Suresh Bhat and seconded by Dr. Anil Patil.

The Joint Secretary Dr. Avinash Parthasarathy presented the Vote of Thanks and thanked the President, President Elect, Secretary General and all the members for attending, deliberating and unanimously passing the Draft of the Constitutional Amendment and Blue Book in the Extraordinary General Body.

MINUTES OF THE KOA AGM 2023

Venue: Hall 'A', KLE Centenary Convention Centre Belagavi.

Time: 05.00 pm.

Members Attended: 120.

The meeting started at 05.00pm, as the quorum was reached.

The President, Dr. Aswani Kumar Singh called the house to order. The President addressed and welcomed the members to the Annual General Body Meeting of Karnataka Orthopaedic Association. The President asked the Secretary General to continue with the agenda.

The Secretary General, Dr. Bharath Raju G. welcomed the members.

The Secretary General mentioned that there was no **Obituary** in the year 2022 – 2023 and all the members were hale and healthy. He asked the members if there are any obituary which has not been notified. There were none.

The **Secretary General's Report** was read out by Dr. Bharath Raju G.

The Secretary General said that this was the second year he was presenting the Secretary General's report. He thanked the President, for all the support extended. The Secretary General also thanked the Past President, Past Secretary General, President Elect, OASIS Vice President, Joint Secretary, Treasurer, the Editor Journal of KOA, Executive Committee Members.

The Secretary General mentioned that for the first time the President had appointed KOA Zonal Coordinators, one from each zone of KOA – Dr. Sachidananda Rai for South Zone, Dr. Vinod Kumar A.C. for Central Zone along with Dr. Gururaj Murgod for North Zone, Web Coordinator Dr. Satya Vamsi Krishna and KOA Academic / PG Coordinators – Dr. Satish Shervegar, Dr. Prakashappa T.H., Dr. Neelanagowda Patil, Dr. Anil B. Patil, Dr. S.F. Kammar, Dr. Sachin Shah, Dr. Harish P. along with Dr. Dayanand B.B. He thanked them for their support and cooperation in achievements of KOA.

The Secretary General mentioned that the renewal of the Association has been done on time.

The Secretary General mentioned that the year began with the KOA AGM 2022 on 5th March 2022. In view of the covid restrictions, the AGM was conducted in a Hybrid mode on Zoom platform from Hotel Royal Fort, Ballari. The AGM was attended 28 members physically and 150 members online.

The Secretary General said that as the KOACON 2022 was postponed due to covid restrictions, the Presidential Change of Guard was held at the AGM and Dr. Aswani Kumar Singh J. took charge as President KOA 2022 - 2023.

The **46th annual conference of KOA, KOACON 2022** was postponed and conducted from the **6th to 8th of May 2022** at St. John's Auditorium, Bengaluru. The theme of the conference was "*Optimizing Clinical Outcomes – Scope for New Breed of Orthopaedic Surgeons*". The conference was attended by around 550 registered delegates and 210 faculty. The conference was inaugurated by Dr. M.K. Ramesh, the Vice Chancellor of Rajiv Gandhi University of Health Sciences along with Dr. Naveen Thakkar, Secretary General IOA and Dr. Selvaraj, President OASIS as guests of honour. Six senior KOA members were felicitated for lifetime achievement - Dr. S.S. Gubbi from Gulbarga, Dr. B.B. Putti from Belagavi, Dr. Rajagopalan from Bengaluru, Dr. I. Suresh from Bengaluru, Dr. Ajith Kumar M. from Mangaluru and Dr. Purshotham Sastry from Mysore.

The Presidential Oration was delivered by Dr. H.S. Chandrashekar, Prof. Varghese Chacko Oration was delivered by Dr. Sharan S. Patil and Prof. Shyam Sundar Shetty Oration was delivered by Dr. Satish Shervegar.

The **14th KOA ICL 2022** was organised by the Department of Orthopaedics, Navodaya Medical College, Raichur in association with Raichur Orthopaedic Society on **20th & 21st of August 2022**. It was inaugurated by Shri S.R. Reddy, Chairman, NET. The total number of delegates was 160 including Faculty, Consultants and Postgraduates from all over Karnataka.

The Secretary General said that for the first time KOA conducted a **CME and Workshop** on **“Current Concepts in Foot & Ankle Trauma & Orthopaedics”** on **5th of June 2022**. This was the initiative of the IOA Foot and Ankle Committee in association with Indian Foot and Ankle Society. The CME and Workshop was conducted in all five zones of IOA on the same day with the same course content. The South Zone CME was conducted by KOA at Kempe Gowda Institute of Medical Sciences, Bengaluru.

The Secretary General said KOA conducted only one **Webinar** as most of the activities were physical meetings. The webinar was on **“Investment Planning for Orthopaedicians”** in association with NiveshMitr on Thursday the **15th of September 2022**. The webinar was interactive with around 100 members participating.

The Secretary General said that Karnataka Orthopaedic Association celebrated the **Bone and Joint Week** from **1st to 7th of August, 2022**. The District Chapters conducted various theme-based programs throughout the week. All the programs were covered in print, social and visual media. The **BLS Training Video** sent by IOA, was dubbed into Kannada by Dr. Venkatesh K.P., from Bengaluru. The video was circulated to all the members who spread it on social media and was well received and appreciated by the members, trainees and general public. The **Bone and Joint Day** was celebrated on **4th of August 2022 at Belagavi** and he along with the President attended the event. A press meet was conducted on the same day at Belagavi.

The Secretary General listed the **KOA Business Meetings** conducted during 2022 – 2023. Six Executive Committee Meetings were conducted two physical and four online meetings, two KOACON 2023 Central Conference Committee meetings conducted, three IOACON 2024 meeting were conducted. He mentioned that for the first time the President has conducted two District Chapter Office Bearers meetings.

The Secretary General said that the **Publications of KOA** were KOA Bulletin published in January 2023 and two issues of Journal of KOA have been published under the Editorship of Dr. Anil K. Bhat.

The Secretary General said that the **KOA Website** “www.koaindia.org” has been redesigned and given a new modern look. He said that the President was keen on having a simplified mode to apply for KOA membership and the KOA Membership Application is made completely Online. The salient features in the new website are Member Profile, Blogs, Fellowship Notification, Job Opening Notifications and Member Achievements. The Secretary General requested the members to visit and utilize the features on the website.

The Secretary General said that after two years **KOA International Meet** was conducted in association with BOS at Almaty, Kazakhstan. It was attended by over 60 delegates including family.

The Secretary General said he has attended and represented KOA at all **OASIS** Executive Committee Meetings. He has presented the State Activities Report at all OASIS EC Meetings. He said that KOA has conducted the 2 OASIS ICLs in April and September 2022, with OASIS President Elect Dr. N. Nithyanand Rao as the Course Chairman. He attended OASISCON 2022 the 21st Annual Conference of OASIS from the 3rd to 5th of September 2022 at Kurnool. He said that for the first time KOA was awarded the “**OASIS Best State Chapter Award – 2022**”. The members applauded the same. He said that Dr. J.N. SridharaMurthy from Bengaluru was felicitated for Lifetime Achievement at OASISCON 2022.

The Secretary General said that he has attended and represented KOA at all **IOA** Executive Committee Meetings and CSRC meetings. He has regularly presented the State Activities Reports. He said that as the Convenor of IOA Foot & Ankle Committee he has conducted a CME & Workshop on 5th June 2022 in all the 5 Zones of IOA with around 500 delegates. He said that in the South Zone it was conducted by KOA at KIMS, Bengaluru which was attended by more than 100 delegates. He said that he has attended IOACON 2022 the 67th Annual Conference of IOA from the 28th November to 3rd of December 2022 at Amritsar and presented the KOA Activities Report and IOA Foot and Ankle Committee Report.

The Secretary General said that the campaign for the KOA Bid to host IOACON 2024 started on 1st May 2022 with the KOA President from the IOA House New Delhi. He said that all the KOA members have contributed in the campaign for the bid. The campaign ended with a Team KOA winning the bid to host IOACON 2024 with a huge margin of 720 votes. The same was applauded by the members.

The Secretary General said that the **KOA Membership** is completely online now. For people who cannot do online application, they can download the KOA Membership Application form along with IOA Application Form and apply for membership. The total KOA Members were 1888. KOA Life Membership Applications received this year is 204. The OASIS Life Membership Applications from KOA ratified in OASIS 2022 AGM is 111. IOA Life Membership Applications from KOA ratified in IOA 2022 AGM is 63, IOA Associate Membership Applications from KOA ratified in IOA 2022 AGM is 7. The IOA Life Membership Applications from KOA forwarded after the AGM is 5.

The Secretary General said that the KOA BIOS Bisal Muddu International Travelling Fellowship has been restarted after a gap of two years and applications have been invited for the same. The KOA Surekha Rajendra Kokhale Inland Fellowship could not be conducted this year as the institutes were not accepting fellows.

The Secretary General said that he has attended BOSCON 2022 the annual conference of BOS at Bengaluru on 9th April 2022, MOA Monthly meet on the 23rd July 2022, attended COS Prof. M. Sudhakar Shetty Oration on 12th November 2022 delivered by Dr. Naresh Shetty, BOS Monthly Meet on 18th December 2022 at Bengaluru and CME conducted by UKOA at Karwar on 8th January 2023.

The Secretary General thanked the members for their cooperation and support through the year.

The Treasurer presented the list of six KOA FDs in Canara Bank, Vijayanagara, Bengaluru branch amounting to Rs. 1,30,00,000/-. He said one more FD of amount Rs. 25,00,000/- in Canara Bank, Manipal Branch is with Dr. Sharath Rao, KMC Manipal.

The Treasurer thanked the Secretary General for conducting a workshop and CME was conducted in KIMS, Bengaluru under the IOA Foot and Ankle committee and contributing an amount of Rs. 38,000/- to KOA account in the month of June 2022. He thanked Dr. Anil Bhat, Editor KOA Journal for closing the Journal account and remitting Rs. 2,13,962/- to the KOA account on 19th September 2022.

4. A mail from Dr. Suresh Bhat seeking financial aid for small District Chapters with less than 30 members to conduct CME. The President said that the same was discussed in the EC and it was resolved to allot Rs. 25,000/- to one small District Chapter in each KOA Zone to conduct a CME / Workshop i.e., three CMEs in a year. The AGM approved the same proposed by Dr. Suresh Bhat and seconded by Dr. Gangadhar Umrani.

MINUTES OF THE KOA AGM 2023

5. In the same mail Dr. Suresh Bhat has written to conduct an annual cyclathon under the KOA banner to promote fitness among the members. The President said that this has to be included in the KOA activities and he has initiated a KOA Sports Meet in the current KOACON. The AGM approved the same proposed by Dr. Satish Nesari and seconded by Dr. Puneet Chamakeri.
6. A mail from Dr. Sharath Jadamali to conduct short term fellowships for young members to train and improve their skills. The President mentioned that due to various reasons the fellowships could not be conducted this year and requested the incoming President to start the programs from the coming year. The AGM authorised the incoming President Dr. Edward Nazareth to start short term fellowships, proposed by Dr. Parthasarathy and seconded by Dr. Vinod Kumar.
7. A mail from Dr. Vanamali Seetharam, President of Bangalore Orthopaedic Society (BOS) on behalf of BOS to name the KOA Best District Chapter Award in the name of Prof. V.H. Hanumanthaiah and the BOS was willing to contribute a sum of Rs. 5,00,000/- for the same. The President said that the matter was discussed in the EC and the resolved to approve the same for a period of 5 years as the amount was small. Dr. J.N. Sridharamurthy said that Prof. Hanumanthaiah has been a past President and contributed a lot for the KOA, it would not be right to have any riders for the same. Dr. Kaladagi said that it will be a disrespect to have riders for Prof. Hanumanthaiah and it should not be discussed any further and passed unanimously. Dr. Gururaj Murgod said that the same should be instituted in the name of Dr. A.M. Kulkarni. Dr. Muralidhar said that there should not be any dissent for Prof. Hanumanthaiah's name and Dr. Kulkarni's name can be instituted for another award. The AGM unanimously approved the naming the KOA Best District Chapter Award as Prof. V.H. Hanumanthaiah KOA Best District Chapter Award, proposed by Dr. A.M. Kulkarni and seconded by Dr. Kaladagi.
8. A mail from the President Elect Dr. Edward Nazareth for utilisation of the KOA funds for maintenance of KOA Secretariat, academic activities decided by the EC, publication of Journal and for expenses of physical EC meetings. The Secretary General said that the KOA Secretariat is being maintained by the KOA funds. KOA Secretariat provides a fund of Rs. 1,00,000/- for the KOA ICL. The AGM has just approved Rs. 25,000/- funds to conduct three CMEs and if required to allocate Rs. 25,000/- to conduct one KOA PG Teaching Program. The Secretary General said that to avoid unnecessary expenditure the physical EC meetings can be restricted to two during the KOA ICL and KOACON, wherein all the members will be attending. The other EC meetings can be conducted online as it is convenient to all the members. The AGM approved conducting physical EC meetings only during ICL and KOACON, rest of the EC meetings will be online and also to allocate Rs. 25,000/- to conduct one KOA PG Teaching Program to be decided by the President and the EC. Proposed by Dr. Sachidananda Rai and seconded by Dr. Kanakachalapathi.

MINUTES OF THE KOA AGM 2023

The announcement of **KOA Best District Chapter Award**. The Secretary General said that for the first time a Self Scoring Sheet was drafted and all the district chapters have submitted the same along with supporting documents. He said that there was a close contest as all the district chapters have conducted many activities and the President has decided to award two awards this year. The Best District Chapter Award is awarded to Bangalore Orthopaedic Society and the Second Best District Chapter is shared by Belgaum Orthopaedic Surgeons Society and Mysore Orthopaedic Association. The AGM passed the same proposed by Dr. Vikram Shetty and seconded by Dr. Arun.

The Secretary General said that KOA has won the bid to conduct **IOACON 2024** at Bengaluru. The Secretary said that the accounts for the conduction of IOACON has to be opened using the KOA PAN Card and KOA GST Number. He also said that for coordination with the Organising Committee of IOACON and the KOA Secretariat, the Organising Chairman, Organising Secretary, Organising Treasurer, the then IOA President and IOA Treasurer have to be co-opted to the KOA Executive Committee. The AGM unanimously resolved to co-opt the above persons to the KOA EC and authorised to use the KOA PAN and KOA GST Number for opening of the IOACON 2024 accounts. The same was proposed by Dr. Muralidhar and seconded by Dr. Devendrappa.

The Secretary General asked the members if there were **any other matters** to be discussed with the permission of the President. The members said that most of the topics have been discussed.

The report of the upcoming **KOACON 2024** was presented by Organising Secretary Dr. Harish Pai. He mentioned that the conference will be conducted from 2nd to 4th of February 2024 and presented a brief report of the KOACON 2024. He invited all the members to register for the conference as they are offering an early bird price.

The **Incoming President Dr. Edward L. Nazareth** addressed the AGM and introduced his incoming team. He said that the President's Theme for the year 2023 - 2024 will be "Ethical Orthopaedics – Safe Orthopaedics".

The Vote of Thanks was delivered by the Joint Secretary Dr. Avinash Parthasarathy. He thanked the President, President Elect, Secretary General and all the distinguished members for actively participating and smooth conduction of the AGM.

AGM concluded with singing of the National Anthem.

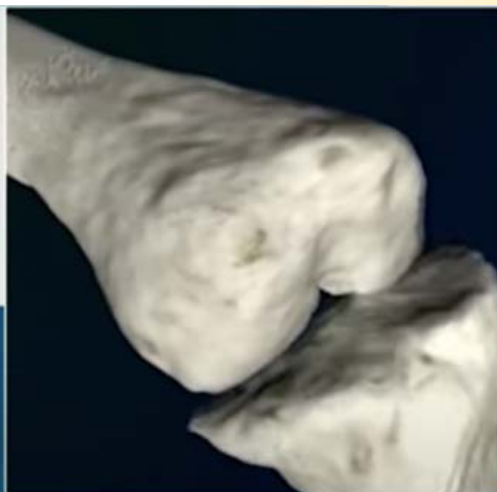

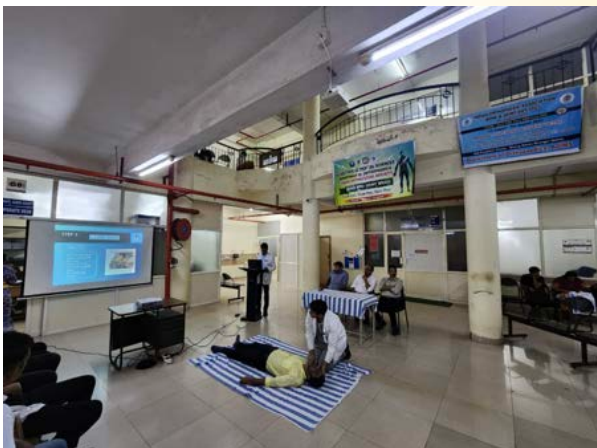
